Voter Authenticotion

Not required when voting by mail



Vital data requires multiple layers of protection. Access is not granted without multiple-factor authentication.

The validity of each ballot is vital to ensuring the results are accurate and authentic.

Ballots returned by mail or drop box are not observable and lack the ability to prove a voter's identity or eligibility.



When granting authority to act on an individual's behalf, you provide an ID and sign 'inperson' but when electing someone to act on behalf of the public, if doing so by mail, there is a different standard.



MACHINE MANIPULATION POSSIBILITIES

1

Malicious Code

Machine vendors can program the machines with the ability to flip votes from one candidate to another. Many machines are already capable of overriding a voter's selection and recording a vote for someone the voter did not intend to vote for. This can be done through controlling races. The vendors could also program fractional voting that doesn't show up until a certain number of ballots is counted, to avoid detection in pre or post election system tests.

2

Remote Access

Machines may allow for remote access for troubleshooting, or nefarious purposes. This could be used to flip votes, adjudicate ballots, delete votes, insert votes, and other forms of manipulation from a distance. Without the source code, we don't know if the machines are capable of these things.

3

Manipulating System Software

Using a number of methods, a bad actor could install software on the system which would alter the way the machine counts. Could be downloaded from a thumb drive, over the internet, or another connection. This could be done on a central tabulation system and alter the entire election, or on a particular location to disenfranchise voters of a particular party.

4

Intentional Incorrect Setup of Elections


When someone is setting up a new election, they could manipulate the ballot definition file. This could cause votes to be counted for the wrong candidates, omit certain parts of the ballot from the locations the scanner is looking for marks, and override voters' selections. Voting centers can be set up to not read ballots the same as other locations.


Adjudication

Adjudication allows for voter's selections to be altered. Systems using hand marked paper ballots have a large number of ballots sent for resolution. Election workers can change votes both honestly and nefariously. There is the possibility that the system could secretly adjudicate ballots without the knowledge of the election staff. Evidence of this was discovered in Mesa County Colorado.



















MANY VOTING SYSTEMS ALREADY HAVE THIS FEATURE BUILT IN. THOSE THAT DON'T WILL NEED TO HAVE A DIFFERENT TABULATION SOFTWARE INSTALLED IN ORDER TO COUNT THE VOTES IN THIS MANNER. WHY DO SOME VOTERS GET MORE THAN ONE VOTE, WHILE OTHERS ONLY GET ONE? BECAUSE IT IS NOT A FAIR WAY TO VOTE OR TO COUNT. VOTERS WHO VOTE FOR A LOSING CANDIDATE GET MULTIPLE VOTES WHILE VOTERS VOTING FOR A CANDIDATE IN THE TOP TWO ONLY GET ONE OF THEIR VOTES COUNTED.

NOT ONLY IS THIS METHOD OF VOTING NOT A FAIR WAY TO COUNT, BUT IT ALSO INTRODUCES MORE RISK FOR FRAUD AND/OR MANIPULATION.

WHEN VOTES ARE TRANSFERED FROM A LOSING CANDIDATE TO THE VOTER'S NEXT CHOICE, IT'S DONE WITHIN THE MACHINE.

IF THE MACHINES ARE PROGRAMMED TO GIVE VOTES TO OTHER CANDIDATES, WHAT ELSE ELSE DO YOU THINK IT CAN DO?




WITHOUT ACCESS TO THE CODE, CITIZENS CANNOT KNOW FOR SURE WHAT THE MACHINE IS CAPABLE OF AND IT DOES NOT ALLOW FOR A TRANSPARENT TABULATION PROCESS THIS METHOD IS A MORE COMPLICATED SYSTEM, AND REQUIRES THAT VOTERS ARE WELL EDUCATED ON HOW THE COUNTING HAPPENS.

THE VOTING PROCESS AND TABULATION PROCESS NEED TO BE EASY TO UNDERSTAND FOR EVERYONE. IT'S OVER-COMPLICATED ALREADY.










Albert sensors monitor the county's network, not the election systems. Aside from the many risks and inconveniences that come with installing the sensors, it may have some benefit for the county network. It does nothing for the election system, unless they are ready to admit the election systems are connected to the internet.



REASONS ELECTIONS SHOULD NOT LAST MORE EXPENSIVE LONGER THAN TRANSPARENCY LOSES CONFIDENCE LATE BALLOTS CAN BE ADDED LOTS OF TIME FOR MANIPULATION DISCOURACES PUBLIC PARTICIPATION MORE OPPORTUNITY FOR INTERFERENCE INCREASE RISK OF MACHINES BEING HACKED BALLOTS & EQUIPMENT ARE LEFT UNATTENDED LOSS OF CONFIDENCE FROM CANDIDATES DEPRIVES PEOPLE OF THE ELECTION DAY EXPERIENCE CONVOLUTES AND COMPLICATES THE COUNTING PROCESS IMPOSSIBLE FOR OBSERVERS TO BE PRESENT ENTIRE TIME ELECTIONS OFFICE ENDS UP WORKING OUTSIDE OF PUBLIC VIEW

THE TIESIDE

EACH NEW ELECTION REQUIRES A NEW BALLOT DESIGN TO ENTER THE CORRECT CANDIDATES AND RACES. THIS IS SET UP BEFORE THE ELECTION BY THE COUNTY STAFF OR SOMETIMES BY THE MACHINE VENDORS.

THIS REQUIRES A NEW BALLOT DEFINITION FILE / ELECTION DEFINITION FILE SO THE TABULATORS KNOW WHO TO CREDIT THE VOTES FOR ACCORDING TO WHICH BUBBLE IS FILLED IN.

THE LOGIC AND ACCURACY TEST IS THE ONLY REASSURANCE THE PUBLIC HAS THAT ELECTION FILES HAVE BEEN PROPERLY PROGRAMMED BY WHOEVER IS RESPONSIBLE FOR THEM.

IF THESE ARE NOT SET UP CORRECTLY AND JUST RIGHT. THE SOFTWARE COULD READ VOTES AND COUNT THEM FOR THE WRONG CANDIDATES. SORT OF A BIG DEAL.

THERE IS NOT ENOUGH OVERSIGHT FOR THE ELECTION SETUP PROCESS. AND THESE FILES DO NOT HAVE AUDIT REQUIREMENTS. ALL WE HAVE TO RELY ON IS THE LOGIC AND ACCURACY TEST.

IF THERE IS AN ISSUE WITH THE LOGIC AND ACCURACY TEST. IT MUST BE CORRECTED BEFORE BALLOT PROCESSING BEGINS AND A NEW TEST SHOULD BE ADMINISTERED.

LOGIC AND ACCURACY TESTS

AGAINST

IF THE TEST RESULTS ARE PUBLIC KNOWLEDGE AHEAD OF TIME. HOW CAN WE BE SURE IT'S NOT PROGRAMMED TO SHOW THE SAME RESULTS EVERY TIME? DOES THE MACHINE KNOW THE RESULTS TOO?

THERE COULD BE A MINIMUM NUMBER OF BALLOTS THAT NEED TO BE SCANNED BEFORE A NEFARIOUS COUNTING PROGRAM KICKS ON WHICH WOULD NOT SHOW UP IN THE LEA TEST DUE TO SMALL TEST DECKS.


HASH TESTING SHOULD ALSO BE DONE IN CONJUNCTION WITH LEA TESTS TO MAKE SURE THE SOFTWARE HAS NOT CHANGED FROM THE CERTIFIED / APPROVED VERSION.

JUST BECAUSE IT ARRIVES AT THE EXPECTED ANSWER DOESN'T PROVE TO US THAT IT GOT THERE CORRECTLY. IT'S JUST SHOWING US THE RESULTS NOT HOW ANY OF IT WAS CALCULATED.

PRECINCTS COULD BE SET UP WITH INCORRECT BALLOT STYLES. WHICH IS NOT TESTED IN A LEA TEST. GREAT IF IT READS THE BALLOT STYLE BUT HOW DO WE KNOW THE CORRECT BALLOTS ARE ISSUED?

THE TEST DECK NEEDS TO BE CHECKED TO MAKE SURE THE BALLOTS BEING ISSUED ARE THE SAME BALLOTS BEING TESTED. TEST DECKS ARE SOMETIMES PRINTED SEPARATELY FROM THE BALLOTS.







TIMING MARKS ON YOUR BALLOT THE MARKS ON THE EDGES OF CANDIDATE A THE BALLOT ARE TIMING MARKS. THE SCHNNER USES THEM TO MAP OUT THE BALLOT. THERE ARE SEVERAL WAYS THIS CAN 60 WRON6: TIMING MARKS TURN THE BALLOT IF THE ELECTION PROGRAMMING IS INTO A GRID. IT TELLS THE INCORRECT, THE MACHINE COULD CREDIT SOFTWARE WHERE TO LOOK FOR THE VOTE TO THE WRONG CANDIDATE. MARKS ON THE BALLOTS. IF THE BALLOT IS MISPRINTED, A VOTER THINKS THEY ARE MARKING THE ONE THE ELECTION PROGRAMMING, OR THEY WANT BUT THE MACHINE CAN BDF, TELL THE SOFTWARE READ IT AS A VOTE FOR SOMEONE ELSE. WHICH CANDIDATE TO CREDIT THE VOTE TO. IF THE BALLOT GOES INTO THE SCANNER AT AN ANGLE, OR FOLDS ON ONE SIDE, THE MACHINE MAY CREDIT HAND COUNTING THE BALLOTS THE WRONG CANDIDATE. 


















EXAMPLE OF HOW SOME COUNTY ELECTIONS OFFICES GO THE EXTRA MILE TO AVOID TRANSPARENCY

BELOW ARE SEVERAL ENTRIES FROM THE CLEAR BALLOT LOGS. THE BLUE LINES ARE ENTRIES FROM KING COUNTY AND THE WHITE LINES ARE FROM OTHER COUNTIES USING THE SAME SYSTEM.

THE ENTRIES IN RED FONT ARE THE PARTS THAT KING COUNTY REDACTED AND THE CORRESPONDING ENTRIES FROM AN UNREDACTED LOG BELOW IT.

IT IS UNCLEAR WHY KING COUNTY FINDS IT NECESSARY TO REDACT THIS INFORMATION. IT (LEARLY IS NOT INFORMATION THAT WOULD PUT THEIR SYSTEM AT RISK. REDACTIONS ARE NORMAL IN CERTAIN RECORDS. STATE LAW DOESN'T EXEMPT THIS INFORMATION SPECIFICALLY. IT'S POINTLESS.

THE COUNTY IS ALSO WASTING TIME AND RESOURCES TO REDACT THIS INFORMATION. SOME OTHER COUNTIES POST THE UNREDACTED LOGS ON THEIR WEBSITE FOR ANYONE TO SEE. IT APPEARS THIS COUNTY GOES OUT OF THEIR WAY TO HIDE THINGS WHICH POSE NO RISK IF DISCLOSED.
